Notes:

- We can agree to follow a data definition, but how can we control data entry?
 - This council has the ability to recommend control of data entry and ensuring that data definitions are utilized. We can also recommend to the unit proposing the definition to set up controls to prevent misuse.
- We have a good representation in this group for administrative and operations units but now sure which member reports back to/covers the academic units (i.e. faculty) for those insights.
 - A communication plan will need to accompany every proposal that comes before the council and the involvement of the academic units will be determined on a case by case basis to ensure they have appropriate involvement.
- Need to control who has access to the data
- Cross-functional mapping and procedures- need to establish a process for doing this
- Need to understand the automated mapping in Workday and the impact of that mapping on people that use the data.
- Can we share how other universities run data governance?
 - The charter has the foundational and operational material for how the council will operate

Voting
